# 173/2023 Public Statements and Questions

- a) A representative of the Parochial Church Council asked for clarification regarding point 168/23 in the minutes of the Parish Council Meeting held 16<sup>th</sup> November 2023. She pointed out that although maintenance of the closed churchyard does not require permission any change to the structure would need permission. The change to the minutes was agreed (175/2023)
- b) A query was raised regarding insurance for the closed churchyard and whether it is covered by the Church or the Parish Council
- c) A member of the public raised questions about footpaths around the village particularly through the woods to the river, to the old cock fighting pit and to Tatham Chairs. Some stiles have been removed and paths fenced across. The Parish Council to investigate.
- d) A member of the public informed the Council that the wall at the top of the steps into the VOSCY is collapsing. The Council to organise a repair.
- e) A member of the public requested coat hooks for the Pavilion. The Clerk to organise.

The application Ref 2022/24077/FUL, dated 23 May 2022, was refused by notice dated 24 May 2023. The development proposed is the change of use from holiday accommodation to residential use.

<u>Decision</u> - The appeal is allowed and planning permission is granted for the change of use from holiday accommodation to residential use at Sycamores Cottage, Barnoldswick Lane, LA6 3LZ in accordance with the terms of the application

# 179/2023 Planning & developments

a) Update on the development of houses on Land at Richard Thornton's School, Burton in Lonsdale, LA6 3JZ, 2020/22109/FUL—No decision has been received. The developer has now applied for planning permission for the School Building. As the accesses to the School Building and the proposed new houses will overlap, the planners have now requested a clearer plan of the two accesses. The legal agreement is currently with the developer's solicitor. The resident of an adjoining property advised that the access road to the School and their property is in very

- poor repair and that overhanging trees are tall and overgrown. The developer to be advised of these issues.
- b) Update on the proposed development of working farmland to include No.8 new holiday accommodation units and associated site entrance, service area, access roads, parking and landscaping at Land southwest of Burton in Lonsdale, LA6 3LH, 2023/24730/FUL Cllr Strickland advised that the planners have requested clarification of the access to the site as it is currently coming off an unadopted road.

#### 180/2023 Highway matters

- a) to receive an update on plans for a chicane at the East Entrance Highways have agreed to provide a more detailed plan of the proposed chicane and where it will be situated. There has been a positive response from residents close to the proposed site.
- b) A member of the public felt that plans for the West entrance should also be advanced, preferably with another chicane. Possible plans to be discussed with Highways.
- c) to receive an update on plans for the South Entrance no final decision has yet been made.

# 181/2023 **Training**

- a) To receive a report of a YLCA webinar on writing grant applications Cllr Leader gave a brief summary of the grant application course which she recently attended. She found it valuable it covered what funding is available, and also how to go about doing applications.
- b) To receive a report of a YLCA webinar providing information on biodiversity Cllr Leader also attended a webinar on biodiversity which covered practical measures that local councils can take and details of measures other councils have taken. She felt that Burton is already doing well with biodiversity but that there a lot more things that can be done. Cllr Leader has useful notes and contacts for both training courses.

#### 182/2023 Recreation Field and Pavilion

One of the picnic tables was in poor condition and has been removed. The other one is in recycled plastic and cost approximately £500. Purchase of a replacement at an approximate cost of £570 plus VAT and carriage was **Approved** 

#### 183/2023 Riverside Land

To receive an update on plans for a tree survey to be carried out at the Riverside Land – a quote of £350 has been received. This was **Approved** – the Clerk to organise the Inspection

#### 184/2023 Parking Space on Village Green

To approve plans and agree an approximate cost to remove the parking space, reseed the area and raise the kerb edging to deter parking – there was some discussion with members of the public expressing the view that the parking space is needed for church goers, funeral vehicles etc. A representative of the Parochial Church Council advised that the parking space is not required for church users, and is generally only used by others. They are in agreement with its removal. Plans and costings to be drawn up for approval at a future meeting.

#### 185/2023 Burton Conservation Group

The idea of a Conservation Group has been circulated by email and there has been some interest in the Group. Cllr Leader felt it should be titled Burton Conservation and Biodiversity Group. She agreed to liaise with other interested parties.
